

County service areas may be established for extended police protection in the unincorporated area to provide an appropriate level of services. The County Service Area Law is a vehicle to perform needed and desired public services.

The constriction of county financial resources has forced the Board of Supervisors to continuously curtail expenditures for public service programs in the face of inflation and workload increases. Inasmuch as various law and justice activities--especially police services--are financed almost entirely by local discretionary funds, it is necessary that expenditures for these services be reasonably contained despite the recognition that public safety is the top priority service.

In order to restore and possibly to improve the level of public services, such as patrol services, in the unincorporated area and to perform the service in a manner somewhat consistent and comparable to cities, it is necessary that a service area be established to provide alternatives for the Board to consider in determining the financing of levels of public service programs.

The Board of Supervisors following formation may establish service charges or propose a special tax. The Board also may authorize an allocation from the Special District Augmentation Fund. It has been proposed in my 1983-1984 Budget Message that an allocation of \$3.3 million be made from this fund to this service area. This is a recommendation which is subject, of course, to revision. In computing this allocation it was contemplated that the fire service would be maintained at an appropriate level as it is a priority service; however, it is anticipated that there will have to be some reduction in the capital acquisition program for 1983-1984. In view of the generous capital acquisition program which has been in existence for fire districts and the virtual elimination of capital items for other public services, such temporary action appears reasonable.

It must be emphasized that the decision as to whether to create a county service area is not related to consideration of the availability of property tax revenues or the allocation to the Special District Augmentation Fund. These are separate financial matters which are subject to public hearings and discussion in the budget process. The question of financing the service area is a separate question to be determined subsequent to formation by the Board of Supervisors after full consideration of the public service needs of our residents.

FORMATION OF COUNTY SERVICE AREA P-6 (LAFCO 83-13' affecting all territory within Contra Costa County, except areas within incorporated cities (including the City of San Ramon) or within Kensington Community Service District.

Applicant: Contra Costa County Board of Supervisors

The County Service Area Law was enacted in 1953 to enable creation of quasi agencies governed by the Board of Supervisors as an alternative method of providing any one or more of an extensive list of specified services as may be required within a particular territory. With this application, the Board proposes formation of CSA P-6 authorized to provide extended police protection to the area served by County Sheriff patrols.

Creation of CSA P-6 would not in itself generate any additional revenues. It would, however, provide the Board with options as it attempts to stretch and shift scarce resources to meet the most urgent of public service needs. Such options that come to mind include allotment of special district augmentation funds, service charge for a property related service or a special tax as was approved at election (two-thirds majority required) by voters in Kensington. Whether any of these options are worth pursuing would properly fall within the public decision-making process conducted by the Board performing dual roles as governing body of both the County and CSA P-6. Your Executive Officer submits that given the urgency for funding public safety services, whether fire or police, the options that CSA P-6 could provide merit being in place in case they are needed.

At date of this report, letters of opposition have been received from Verne L. Roberts, Mayor, City of Antioch and Edward Hoops, Chairman, Riverview Fire Protection District Commission. Both letters (copies enclosed) object to diversion of special district augmentation funds from fire districts which up to now have received the lion's share as allotted by the Board.

Also at date of this report, the County Administrator's Office is preparing supplemental material in support of the proposal. Your Executive Officer plans to enclose the CAO material with this report, provided it is available by the mailing deadline.

On May 13, 1983, Resolution No. 83/687 of the Contra Costa County Board of Supervisors was filed with the Executive Officer of this Commission as valid application for formation of County Service Area P-6; and

At the times and in the form and manner provided by law, said Executive Officer gave notice of public hearing by this Commission upon said application; and

Section 3. The proposed formation of County Service Area P-6 is hereby approved subject to the condition that boundaries of affected territory shall include all unincorporated territory within Contra Costa County excepting therefrom all areas within Kensington Community Services District as such boundaries shall exist at the time formation becomes effective.

Section 4. The Commission hereby finds that there are no property tax revenues that are subject to the property tax exchange provisions of Government Code Section 54790.3.

Section 5. Contra Costa County is designated as the conducting agency and the Board of Supervisors shall initiate proceedings for the proposed formation of County Service Area P-6 in compliance with this resolution.

and Members of the Board:

I am writing on behalf of the City Council of the City of Martinez to urge your opposition to the proposal submitted by the County Administrator, Mel Wingett, for funding of the Sheriff's Patrol Division from the Special District Augmentation Fund.

The City Council feels that it is most inappropriate to remove funds from the Special District Augmentation Fund for a general purpose use. Presently, the City of Martinez receives fire protection from the Contra Costa County Consolidated Fire District. Thus, any reduction in funds available from the Special District Augmentation Fund could adversely impact public safety in the City of Martinez.

While I sympathize with the financial plight of the Sheriff's Department, I do not feel that a raid on the Special District Augmentation Fund is appropriate. I question the additional funding of the Sheriff's Patrol Division without any study as to securing contracts with local policing agencies to provide police services within their spheres of influence. I would urge that consideration be given to the issue of the Sheriff's Department providing patrol services to a host of small unincorporated municipalities.

County budget cuts will eliminate 87 jobs

MARTINEZ — County supervisors received a proposed budget Tuesday that would eliminate 87 jobs, close veterans offices, shut off funds to 4-H programs and leave the county with \$4 million worth of unfunded storm damage repairs.

In addition, programs which house the county's most serious juvenile delinquents are proposed for closure, leaving the courts with the choice of sending more juveniles to the California Youth Authority or leaving them at home.

The board referred the \$270.3 million general budget document, which is \$7.5 million below last year's budget, and a separate \$82 million Health Services Enterprise budget to its Finance Committee for review starting with hearings on May 26.

County Administrator Mel Wingett said "county government is in a straitjacket of mandates and regulations with virtually no control over the systems we operate."

Board members lashed out at the state, blaming it for the county's financial problems.

Supervisor Sunne McPeak of Concord said the state has never assumed its responsibilities to fund the mandates it makes on the counties.

McPeak asked and received board support to request that the County Supervisors Association of California meeting in Sacramento

this week demand the Legislature give the counties their fair share of any alcohol, cigarette and sales tax increases.

The Legislature is now considering increases in those areas to fund education.

Board Chairman Robert Schroder of Walnut Creek said the counties don't have any other alternatives but to ask the Legislature.

"They have the prerogative of developing funds; we don't," he said.

Wingett said, "We (the county) have reached the practical limit of cutting our services," and added that further cuts would make the system unworkable.

Wingett said the county is cutting jobs for the sixth year in a row. And for the second consecutive year, the actual dollar amount of the general budget is down.

"Last year we cut \$4 million from the year before, and this year the cut is \$7.5 million from last year's budget," he said.

Department heads were authorized to issue warning notices to employees whose jobs are unfunded, and June 14 was set as the full

board's public hearing date on Finance Committee recommendations for the proposed budgets.

The board also approved Wingett's recommendation to create a county-wide police service area for the unincorporated areas of the county. The move, which will have to be approved by the Local Agency Formation Commission, would allow the county to tap into the \$20 million Special District Augmentation Fund.

Wingett proposes to take \$3.3 million from that fund, which primarily has been used to support fire protection districts, to help support the Sheriff's Patrol Division.

In spite of the proposed injection of \$3.3 million into the Sheriff's budget, Wingett's proposal still would leave that department \$1.6 million shy of what it received last year.

Also suffering deep cuts would be the Probation Department, which would close the Girls' and Boys' Treatment Centers, the Youth Crisis Services for runaways, and the Juvenile Community Service Program in order to cope with \$1.5 million in cuts.

The cuts would eliminate 28 jobs from the Sheriff's Department and 32 jobs from Probation.

It is the second time that Wingett is proposing to close down the Veterans Resource Centers and the Cooperative Extension Service,

which runs the 4-H programs. Last year funding was restored to both agencies by the Board of Supervisors.

Wingett said that neither service is mandatory and the county would save \$300,000 by ending them.

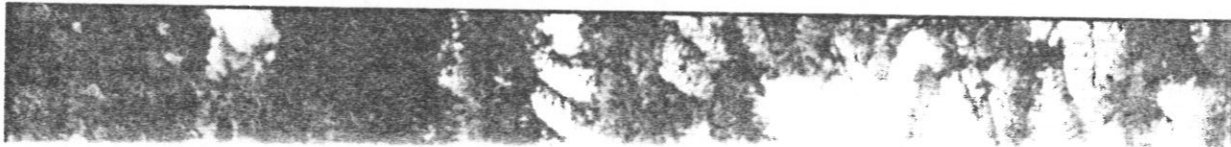
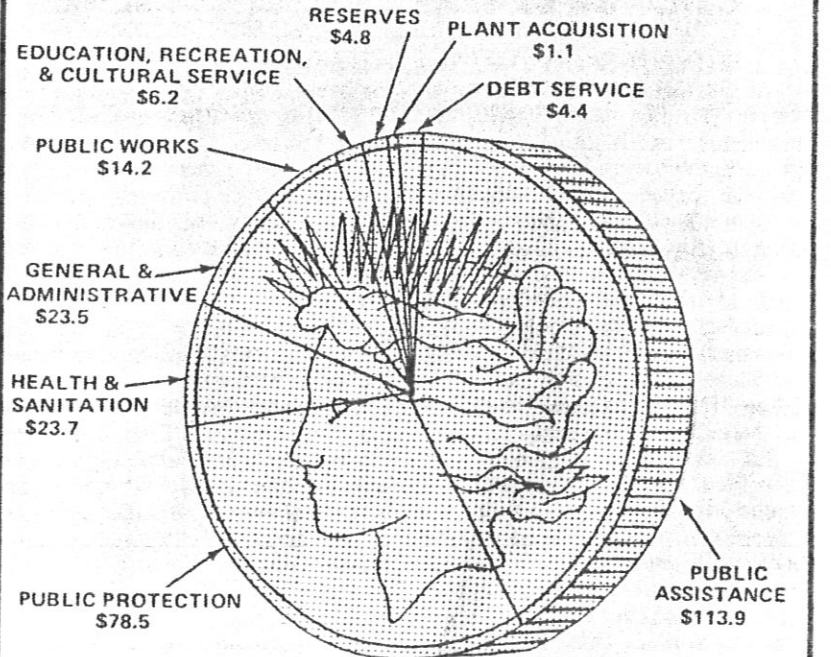
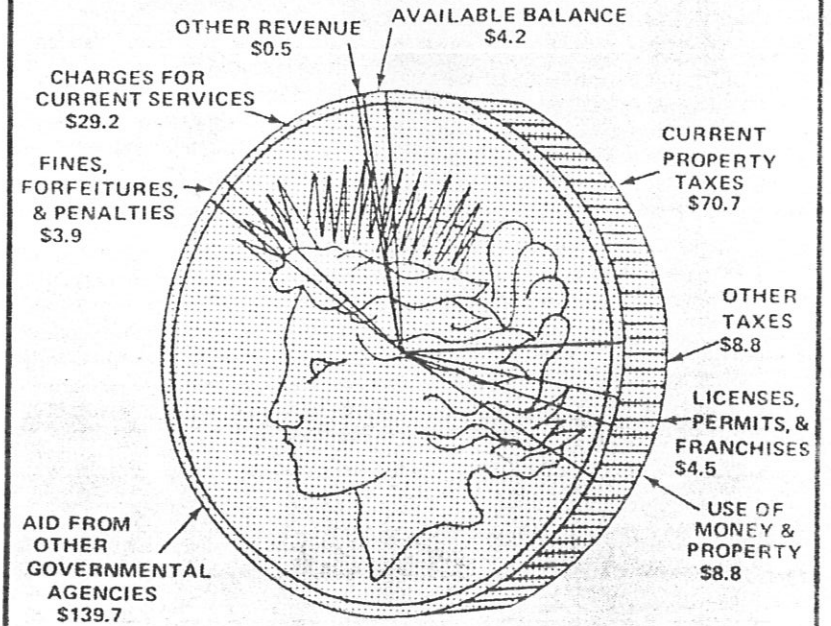
The Veterans Resource Center helps veterans deal with the Veterans Administration. The Cooperative Extension is an "off-campus teaching arm" of the University of California's agricultural programs.

The county provides office space and clerical staff for the Extension Service, and the University of California provides professional staff. The staff provides programs in agriculture, family and consumer sciences and 4-H youth activities.

Only \$650,000 is proposed for storm damage repairs in the 1983-84 budget, "leaving a deficit of \$4 million" said Wingett. He also noted that for the second year in a row the county is not replacing any vehicles except in the Sheriff's Division.

The Health Services budget is not included in the main documents because it is governed by separate enterprise funds. While that budget is \$11.5 million higher than last year, the county dollars in the enterprise fund are actually down by \$2 million.

Most of the increase is due to the county having to take over the care of medically indigent adults, previously cared for under the state Medi-Cal program. In shifting responsibilities to the county, the state provided only 70 percent of the money it used to take care of these people in 1981-82.



THE BOARD OF SUPERVISORS OF CONTRA COSTA COUNTY, CALIFORNIA

The Board of Supervisors of Contra Costa County RESOLVES THAT

On Tuesday, July 19, 1983, pursuant to Resolution No. 83/835, this Board held a hearing on the proposed formation of County Service Area No. P-6 as described in said Resolution. Notice of said hearing was duly given in the manner required by law. This Board at said hearing heard the testimony of all interested persons and taxpayers for or against the establishment of County Service Area No. P-6.

Written protests against the establishment of the area, or against the extent of the area, or against the furnishing of specified types of extended services within the area, or against any other matters considered or resolved by this Board at the hearing on the establishment of the area, were not filed by fifty percent (50%) or more of the registered voters within the territory proposed to be included in the area, or by the owners of more than one-half or more of the value of the land and improvements in the territory proposed to be included in the area, as shown by the last equalized assessment roll. This Board concurs with the determination of the Local Agency Formation Commission that the formation of the area is categorically exempt from environmental review and finds the services described in Resolution No. 83/835 are extended County Services.

A county service area to be known as "County Service Area No. P-6" is hereby established pursuant to the provisions of the County Service Area Law, Chapter 2.2 (commencing with §25210.1) of Part 2 of Division 2 of Title 3 of the Government Code in all of the territory of Contra Costa County excluding therefrom all areas located within incorporated cities (including San Ramon) and within the boundaries of the Kensington Community Services District as such city and District boundaries shall exist at the time formation becomes effective.

The type of extended county services to be performed within County Service Area No. P-6 is extended police protection services.

This Board finds that the proceedings taken prior to the adoption of this Resolution were valid and in conformity with the requirements of said Chapter 2.2 (Govt.C. §§25210.1 ff.).

The Clerk of this Board is hereby directed to transmit a certified copy of this resolution along with a remittance to cover the fees required by Govt.C. §54902.5 to the executive officer of the Contra Costa County Local Agency Formation Commission.



The Board of Supervisors of Contra Costa County resolves that:

The Board hereby applies to the Local Agency Formation Commission of Contra Costa County (LAFCO) to initiate the formation of a county service area to provide extended police protection services. This proposal and application is made pursuant to the Knox - Nisbet Act (Govt.C. §54773 ff.).

The exterior boundaries of the area proposed to be formed into County Service Area P-6 for extended police protection services are all of the territory contained within Contra Costa County excluding therefrom all areas located within incorporated cities (including San Ramon) and within the boundaries of the Kensington Community Services District. A map showing such boundaries, marked Exhibit "A", is on file with this Board's Clerk.

It is hereby requested that LAFCO take all steps necessary to approve the proposal of this Board and allow the initiation of proceedings to form a county service area to provide extended police protection services in the above area.

Pursuant to Government Code Section 54790.3 (b) (2), the Board of Supervisors does not propose that the subject county service area will assume any specific services upon its establishment. For this reason, there are no property tax revenues that are subject to the property tax exchange provisions of Government Code Section 54790.3. The formation of the county service area is being proposed to provide another possible vehicle which could be utilized to provide additional (extended) police services in the unincorporated area should any funds become available for that purpose in the future.

Any additional data or information required by LAFCO and its Executive Officer, pertaining to this matter, shall be submitted by the County Administrator, upon request, to the said LAFCO's Executive Officer.

The person who is to be furnished with copies of the Executive Officer's report and who is to be given mailed notice of hearing is the Chairman of the Board of Supervisors of Contra costa County.

The Clerk of this Board is hereby directed to file a certified copy of this Resolution of Application (together with a copy of the said filed map marked Exhibit "A") with the Executive Officer of LAFCO.
